**V. Reports of the Investigative Committee for Matters of AHC Oversight and AHC Special Fund:**

Jacob Verkerke, Chairperson of the Investigative Committee, reviewed the four recommendations presented at the last meeting. Chairperson Russ Saito asked if HIC had any comments. Russell Castagnaro provided three comments. First, he would like to change the term used in the document from 'outsourced portal provider' to 'contracted portal provider'. Second, while the State Portal Program Manager reports directly to the AHC Chairperson, this position could ultimately report to the State Chief Information Officer position in the future. Third, although he appreciated that the qualification of the person is listed as an independent contractor, without ties to any firm, this qualification may make it difficult for a State government employee to assume the job at a later date.

Jacob Verkerke responded by saying that the investigative committee's intent was to allow a contracted employee provide the services until such time that a State employee position could be established and hired. The qualification that this person is an independent contractor would ensure that another firm would not gain an unfair competitive advantage in the negotiations between the committee and HIC. When a State employee can be hired, the State Portal Program Manager document can be changed to include a State employee as being the State Portal Program Manager.

Russ Saito suggested that a motion be made to approve the reports and the four recommendations with two minor changes: 1. changing the term used throughout the documents from 'outsourced portal provider' to 'contracted portal provider'; and 2. including language so that a State employee can also be hired. Jacob Verkerke made the motion and Ron Boyer seconded. All members voted unanimously to approve the motion with the two changes.

At noon on December 6, 2010, Governor-elect Abercrombie's Administration will be sworn in.

Chairperson Saito said that he really enjoyed working on this committee, and that either an Acting or Interim Comptroller has authority as Chairperson so there should be no disruption to the work of this Committee.


**VII. Adjournment**
