

Pursuant to Act 172/SLH 2007, the Access Hawaii Committee (AHC) submits its annual report to the 2011 Legislature. This year's report is comprised of a report by the portal manager, Hawaii Information Consortium, LLC (HIC), reflecting work it was authorized to do by the AHC in conjunction with various state and county agencies.

The 2011 Annual Report by HIC on the operations of the portal for the 2010 fiscal year with an ending reporting period of June 30, 2010, is provided as Exhibit 1.

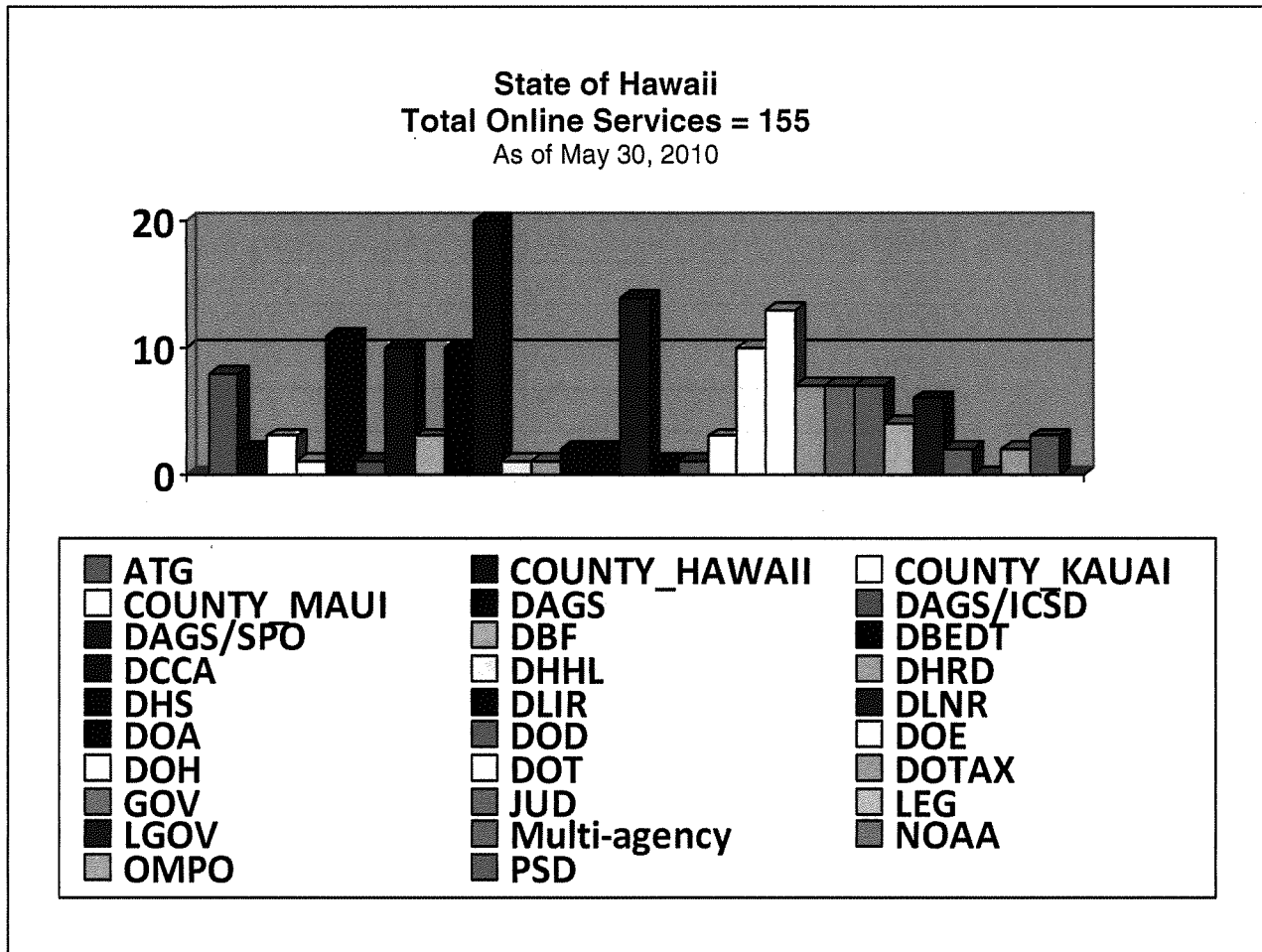
The AHC exercised its oversight of the portal manager through a transition enabled by the passage of Act 172 of the 2007 Legislature. The AHC operated as an informal committee beginning in July of 2005. Act 110, SLH 2003 (SB1334, HD1), had sunset the AHC on July 1, 2005. Because of the value of the oversight function provided by the AHC, the Committee, during the 2007 Legislative Session, submitted draft legislation which the Legislature passed as SB 1315, SD2, HD1, CD1, and which was enacted into law as Act 172 on June 13, 2007. Act 172 re-enacted and codified substantive sections of Act 292, SLH 2000 (SB 2838, SD1, HD1, CD1), which was the original law that established the AHC.

An amendment to the Access Hawaii Committee law under Chapter 27G, Hawaii Revised Statutes was enacted in the 2010 Legislative session as Act 101 (HB2505, CD1). This amendment created the Access Hawaii Committee Special Fund within the Information and Communication Services Division of the Department of Accounting and General Services to support the Access Hawaii Committee.

New online government services are continually being added to the portal. State agencies, county agencies, and their employees working with HIC have continuously identified new online services to be added to the State portal. They have also worked hand-in-hand with HIC through the planning, implementation, and operational phases for these services. As a result, government is more accessible to the public by providing added convenience, allowing citizens to conduct business electronically with the government. Citizens can conduct electronic business with government from their homes and offices, during the State's business and non-business hours.

The portal's success has been achieved through the work of HIC, in conjunction with the AHC and the business and information technology staffs of the State agencies, the Counties, and the Judiciary. The HIC contract was renewed through competitive solicitation effective January 2008 and is currently in the fourth year of a five-year contract.

There are currently 155 documented applications available to Hawaii citizens. The following graph and table provide a breakdown of these applications by department and by hosting entity. Application hosting providers included are HIC and the Department of Accounting and General Services, Information and Communication Services Division (ICSD). Applications requiring financial transactions from citizens or complex business logic are typically handled by HIC. Applications requiring access to public information and transparency of information sharing are typically handled by ICSD.

The following sections provide key issues and activity addressed by the Access Hawaii Committee during fiscal year 2010:

### **Program Manager Position**

Act 101 of the 2010 Legislative Session established the Access Hawaii Committee Special Fund. The special fund will provide the means to fund the hiring of a program manager to oversee the day-to-day implementation of the portal manager contract and to provide administrative and technical support to the Access Hawaii Committee.

### **Content Management System**

An investigative committee has been established to formulate a baseline Statement of Work document and to establish standard charges for content management system services offered by the portal manager to all departments. This baseline document

would be used as a starting point for discussions with interested departments wanting to implement a content management system with the portal manager.

### **Prioritization Model**

An investigative committee was formed to develop a recommended approach for prioritizing portal manager projects. The existing eGITS (electronic Governors Initiative Tracking System) is being considered as a model for a tool. A prototype of a system will be developed by ICSD's Client Services Branch and demonstrated to the AHC when computer hardware is available for this purpose.

### **Governance of Web Sites and Internet Service Providers**

An investigative committee was formed to provide recommendations for Governance of Web Site and Web Site Service Providers. The sub-committee is reviewing information relating to the federal government policies to identify which items are applicable to the AHC.

### **Social Networking (e.g. discussion on Twitter as related to [twitter.com/ehawaiiigov](https://twitter.com/ehawaiiigov))**

The IT Governance Technical Committee will address use of social media technologies. Naming conventions and guidance are needed for social media sites. Investigation and consultation with the Department of Attorney General resulted in a cautionary memo from Comptroller Russ Saito to department and agency heads regarding use of social media sites and possible violations of Hawaii statutes. The National Association of State CIOs is working on a broad based agreement on behalf of all states to address concerns with social media sites in a manner similar to what the federal government was able to achieve.

### **Public-Facing Website Information**

The Access Hawaii Committee is pursuing an inventory of all State public-facing websites. ICSD and HIC provide hosting services, but other sites are also providing hosting services. Upon completion, the inventory list of all sites/services available to the public will be used for monitoring, measuring, reporting and in deterring data mining activities. Data mining activities, whereby unknown external entities pull data and information from State sites to call their own, to re-purpose, re-sell or report publicly available information out of context can impact response time for the public by consuming extraordinary large amounts of bandwidth. Non-disruptive provisions exist to provide publicly available information to those who request it.

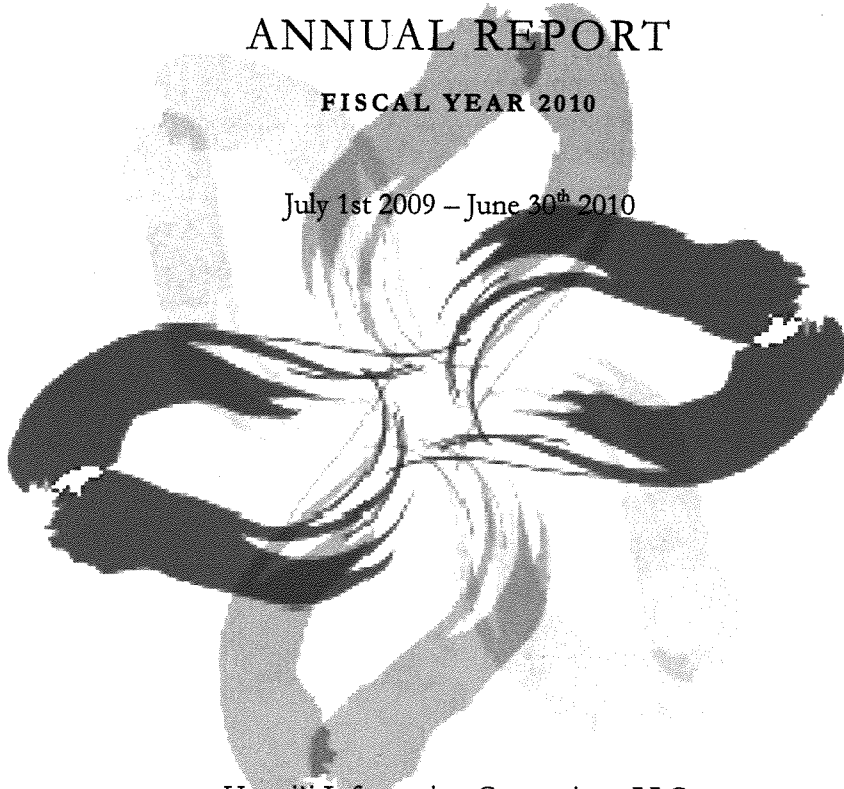

BACKGROUND ON HAWAII'S INTERNET PORTAL

---

2010 marks another record setting year for the Hawaii portal (HIC).

We were honored to receive the Harvard Business School's Bright Idea Award and the Center for Digital Government's Digital Achievement Award for the Electronic Bench Warrants System (eBW) which was developed with the State Judiciary, County Police, Public Safety and many other groups.

Over the course of the fiscal year, 20 applications and websites were released. Of these, 12 were fee based and 8 were free services.

After many years of talks and arrangements this year was the release of the Department of Land and Natural Resources (DLNR) Bureau of Conveyances (BOC) Online UCC filings and a major upgrade of the online document ordering process. UCC has been one of our most requested applications and it has been exciting to see it launched in Hawaii. Currently users can complete a UCC-1 financing statement and submit payment online with more forms to be brought online in coming phases. Before the end of calendar year 2010, the BOC will be accepting eRecordings (electronic conveyance documents) for the first time. We will also be working to completely replace the antiquated BCIS software, which currently runs the office. The BOC will be able to integrate directly with the eRecording system and support national standards, as well as better data access for the counties, agencies and public.

The Civil Resource Violation System (CRVS) Division of DLNR was deployed early last year and has provided a low-cost, simple way to address the non-criminal violations (fish catch reports, parking tickets, etc..) instead of tying up the Judiciary system or the Land Board with these types of violations. The system was developed at no cost and will be self supporting. It includes electronic notification and payment as well as case management and integration with other DLNR divisions.

The state camping system for DLNR Forestry and Wildlife and State Parks Divisions has been a huge success. The public can log in and choose the desired campsite in the comfort of their homes. It has eliminated the infamous lines that used to form at the DLNR Parks Offices a month before major holidays. Not only is the application completely self funded, but it has diverted over 80% of the foot traffic away from DLNR's offices. It also saves the state nearly \$50,000 in support costs per year. The system has been so well received that some counties already have plans to use the system for their reservations as well.

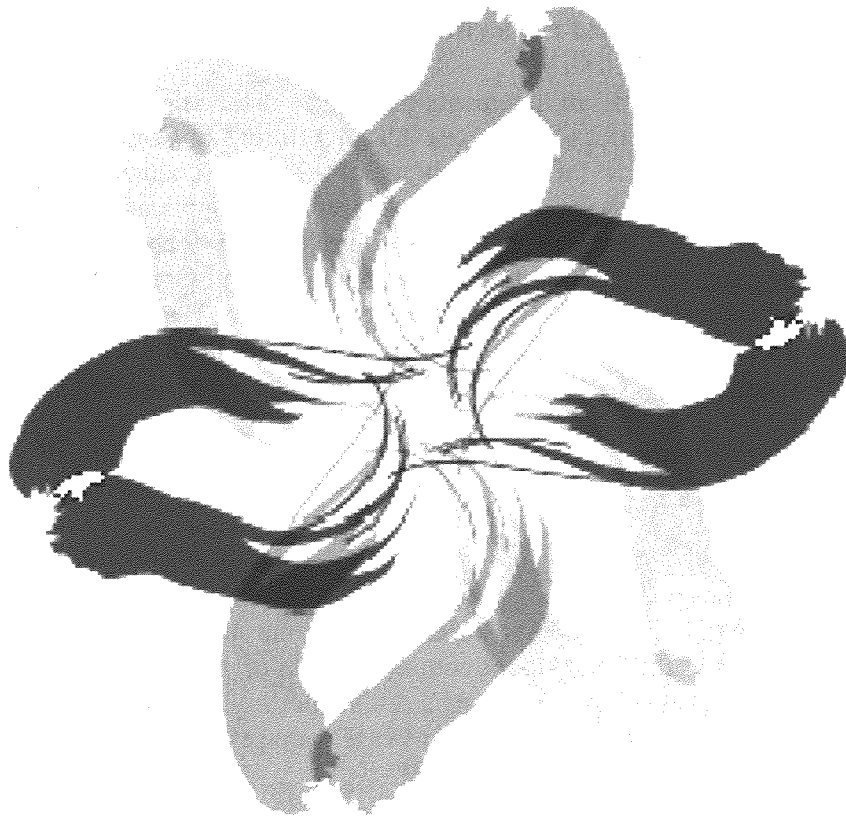

In 2011, Hawaii will be launching an innovative Marriage Licensing system. From couple's registration to marriage agent's approval and marriage performers completion, it covers the complete marriage process in Hawaii and 100% of registrations will be handled through this system. It will be a model for the nation.

The portal and the Department of Taxation also signed an agreement to provide Electronic Personal Tax Filings via the IRS' Modernized Electronic Filing (MEF) program. Similar to the existing eFile application, MEF will be completely self-funded with no state funds being required to develop, host and maintain the service. It should automate the processing of up to 300,000 personal income tax filings each year.

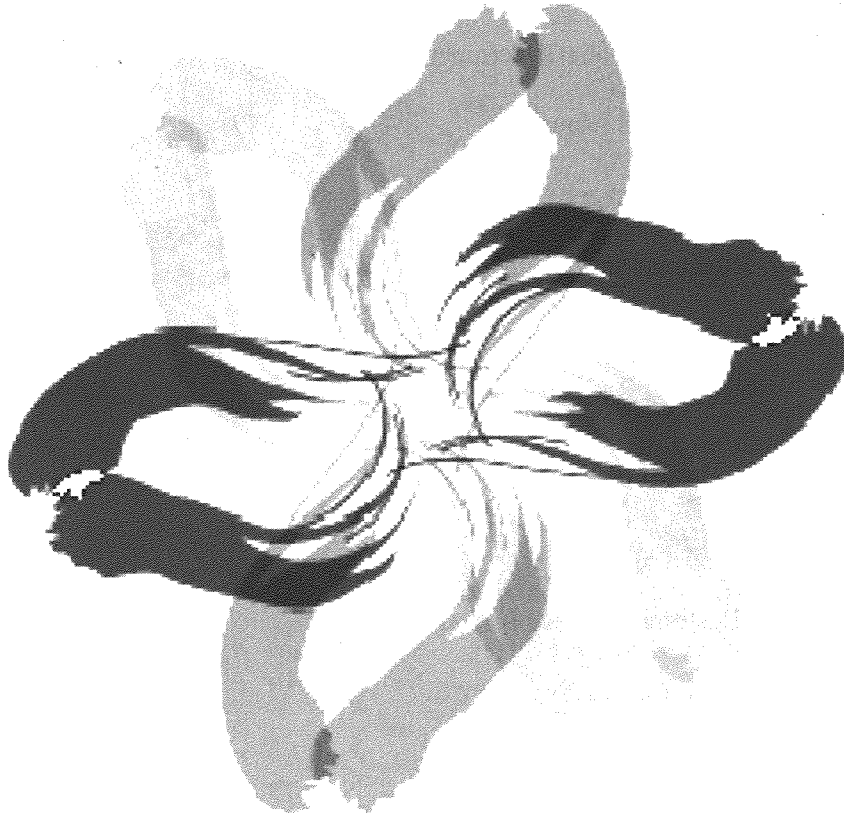

- *HTSB Backend System*  
Phase one included centralizing HTSB's data and administrative functions as well as cleaning their data. 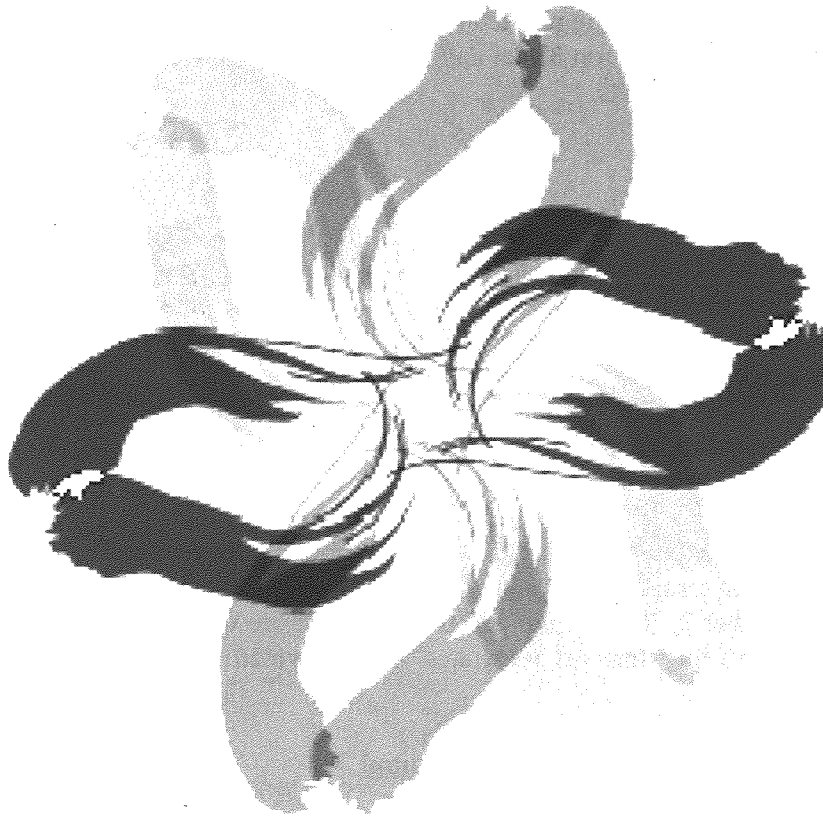

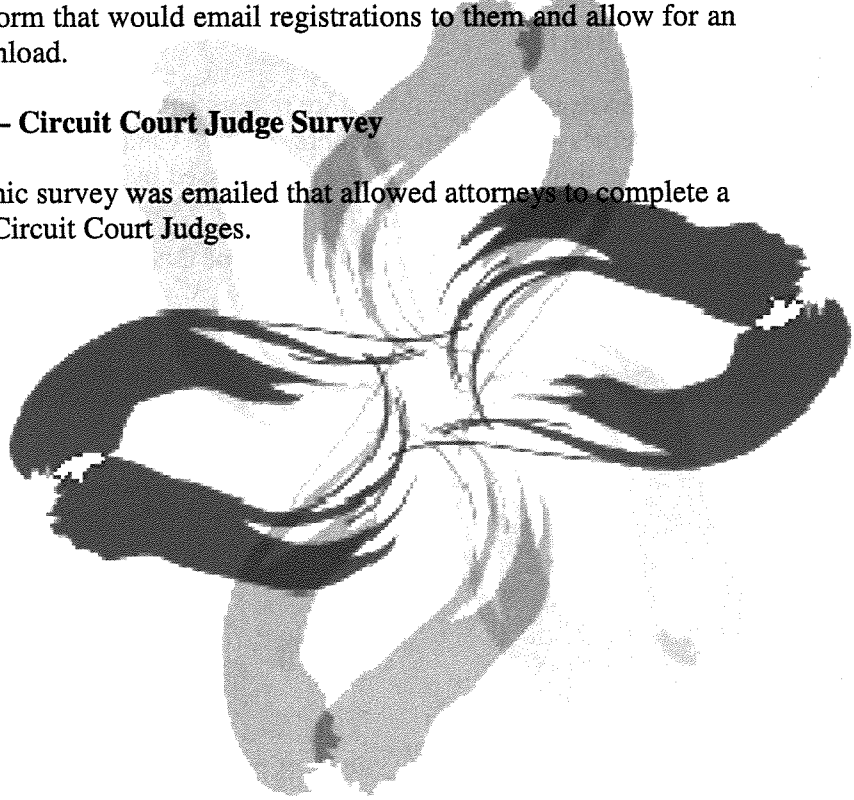

APPLICATION SPOTLIGHT: STATE CAMPING RESERVATION SYSTEM

---

In March 2010, we launched the Hawaii Department of Land and Natural Resources Online Reservation System. Here the public can reserve and purchase camping and cabin permits within two divisions of DLNR, the Hawaii State Parks and the Forestry and Wildlife division:

Within the Hawaii state parks, there are 53 state parks encompassing approximately 25,000 acres on the major islands, each of which offer varied outdoor recreation opportunities. The park environments range from landscaped grounds with developed facilities to wildland areas with trails and primitive facilities.

Camping in the Forest Reserves is usually much more remote and in mountainous locations, providing a wilderness experience and more privacy. Campsites are preferred by those who enjoy 'roughing it' and they are accessed by hiking or 4WD and have few or no amenities.

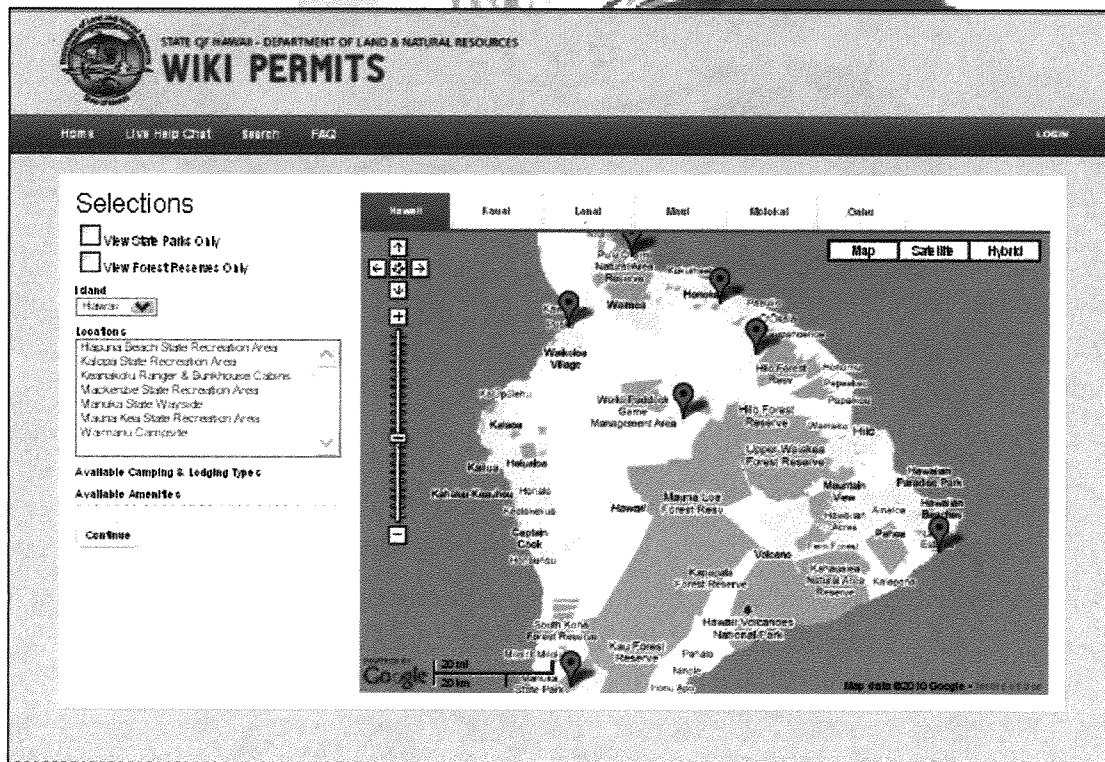


Image A: Camping Landing Page with Map View

With the new service, users can check availability at all State Park locations, make reservations, and submit credit card payments through the state's secure payment system. The new online system eliminates the need for the public to visit or call Hawaii State Park offices for campsite and cabin availability and then mail in permit applications and payments. The online system also saves staff time and money spent on processing mailed or faxed permit applications as well as payments for camping and lodging reservations. Customer service is vastly improved by giving the same convenience to both Hawaii residents as well as out of state park visitors. Prior to this system, most permits were sold in person and the result was long lines and unfairness in permit distribution.

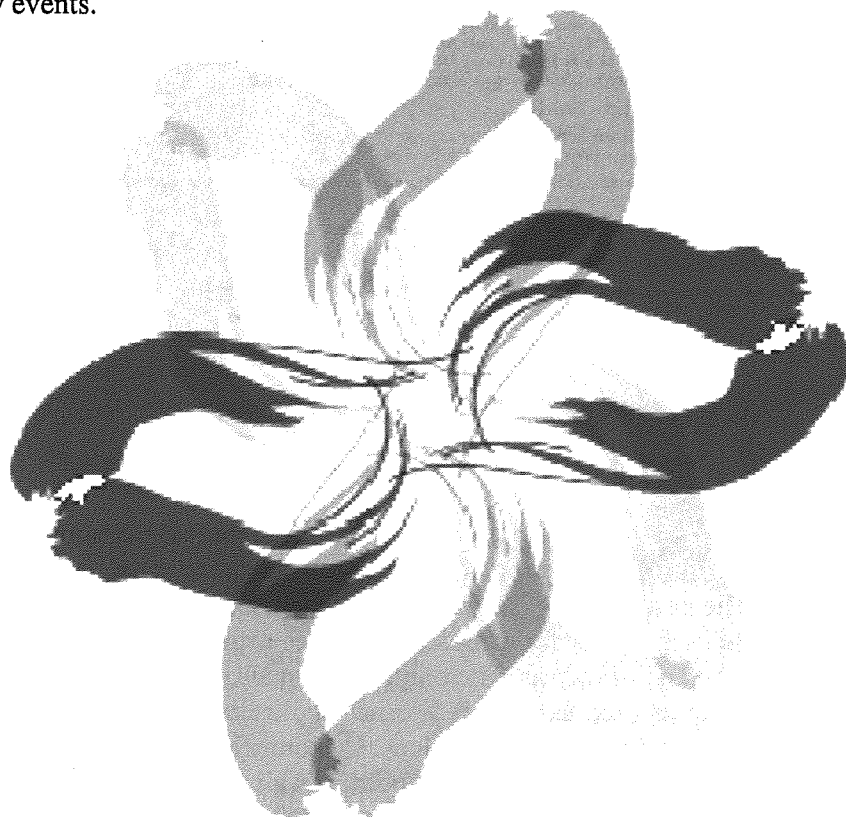
With the launch of the new system, users can now view all campsite information in one location, including:

- Rates and pricing
- Directions
- Amenities
- Photos
- Descriptions (capacity, maximum # of nights, etc)
- Availability

In only a few short months after its initial release, over 5,400 permits have been sold through the new system (March – June 30<sup>th</sup> 2010). Sales of over the counter permits have decreased as well, to 33% of the total permit sales meaning more traffic is being driven away from the office and online, freeing up DLNR staff time to focus on other duties. We are looking forward to 2011 and expect increased success in the coming year!

### **Camping Future Plans**

In 2011, the system will be enhanced to include pavilion reservations as well as various other special use permits, such as group use, wedding and other community events.

PROJECTS CURRENTLY IN DEVELOPMENT

---

**Online Motor Vehicle Renewals: *Hawaii County***

This system will allow registered owners to renew their motor vehicle registration online for the County of Hawai'i.

**Hawaii Electronic Tax Filing System Upgrade:**

2011 individual form upgrades will be completed as well as allowing the addition of pdf previewing for most forms, the addition of a new form GEW-TA-RV-6, and allowing an amended version of the HW-14 to be filed.

**Department of Taxation – Modernized eFiling (MEF)**

A MeF gateway and viewer will be developed, maintained and hosted by HIC for a per transaction fee similar to the existing electronic tax filing application. The new gateway will integrate with Tax's existing ITIMS/JELF systems.

**Controlled Substance Registration System**

Online license registration and renewal for distribution of controlled substances.

**Online Marriage Registration Systems**

Allows couples to register online and authorized officiants to complete and issue certificates online.

**Hawaii County Water Payments**

Residents of the County of Hawaii will be able to make payments to the board of water supply utilizing an online system.

**Honolulu Online Auctioning System**

Confiscated goods at the Honolulu airport security gate will be auctioned online. The agency will no longer have to schedule a once a year auction event.

**Civil Resources Violation Systems (CRVS)**

The new service will allow violation citations to be electronically tracked and paid by violators through an online payment process. It is integrated with existing DLNR services, i.e. monthly catch reporting, so violations will be automatically created when reports are missed.

**Hawaii Judiciary Land Court Petition Filing System**

Will provide a secure and convenient way to complete petitions to amend a Transfer Certificate of Title and pay filing fees.

The existing eBench warrants system enables all levels of the law enforcement agencies to search, view, and process new and existing traffic warrants online. The final phase in development will bring the County of Hawaii on to the system in summer 2010, thereby making the warrants system available in all major counties.

We will be developing a licensing registration and public search for notaries public in coordination with the Attorney Generals office.

**Kalaiwa Public Traffic Abstracts**

The system will allow the public to purchase official Hawaii state motor vehicle records, also known as traffic abstracts, online.

**DCCA Real Estate Branch**

This system will allow initial licensing for real estate license holders online.

**DBEDT Hawaii Film Permits**

HIC will be developing an online system to reserve permit locations for filming movies at specific Hawaii locations.

**Camping Reservation System**

The existing camping system will be enhanced to include new features for reserving pavilions for use as well as integrating special use permit reservations.

**Vital Records Ordering System**

The existing vital records system for ordering birth and death certificates will be enhanced with new features including an expedited mailing option as well as bringing the verification of birth requests online.

**HTSB Initial Teacher Licensing**

Changes will be incorporated in to the HTSB system to allow for initial teacher licenses to be submitted online.

**DLNR, Division of Boating and Ocean Recreation – Accounts Receivable System (BARS)**

The BARS system is a boating account management system and customer online payment processing. Payment services will include payments for harbors and boat slips.

Kauai city and county camping reservations will be integrated in to the existing state camping reservation system.

**Online Rental Car Renewal System**

Car rental agencies on all islands will be able to do bulk renewals for their fleets of rental cars. As a subscriber, they can upload a list of their fleet of cards and get automated renewal notices informing them when it is time to renew.

**DLNR BOC – Conveyance Documents**

The BOC's existing recording system (BCIS) runs on unsupported hardware and software. Over the last two years the system has had multiple issues, which brought Bureau operations to a halt. This is a major overhaul/replacement that will enable native eRecording and upgrade to a better back-office system. The new system will be able to integrate directly with the eRecording system (currently in pilot) and will support national (PRIA) standards and better data access for Hawaii Counties, other state agencies and the public. The new system will be 100% web-based and will give the Bureau more ways to provide information to the public and generate more revenue.

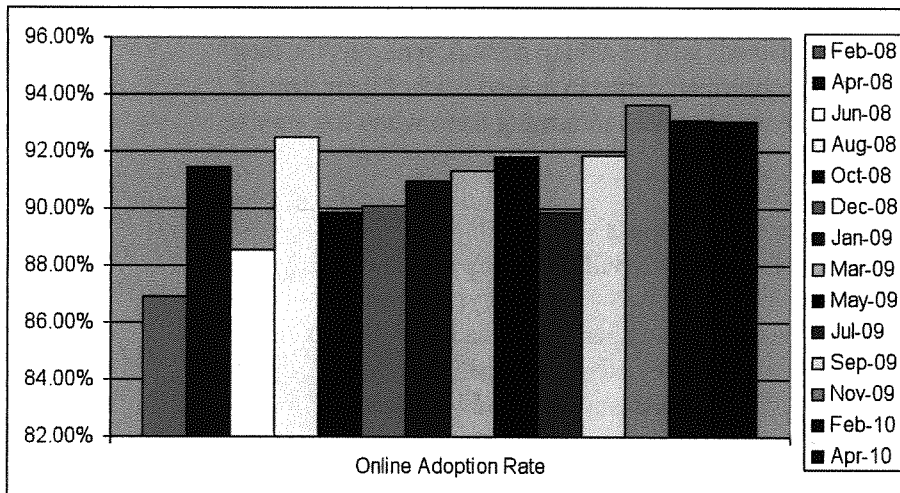


Chart 1: Online Insurance Renewals for the DCCA

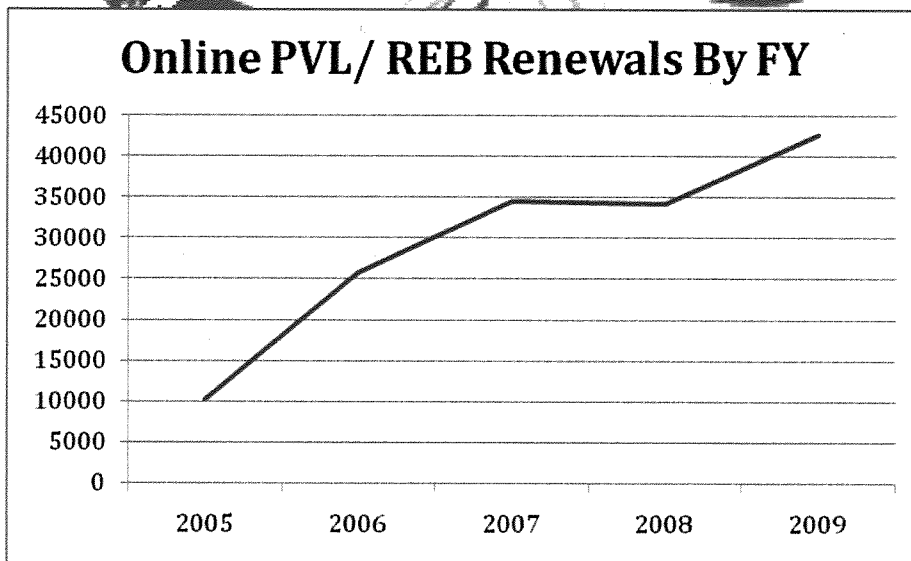


Chart 2: Online DCCA PVL and REB Renewals

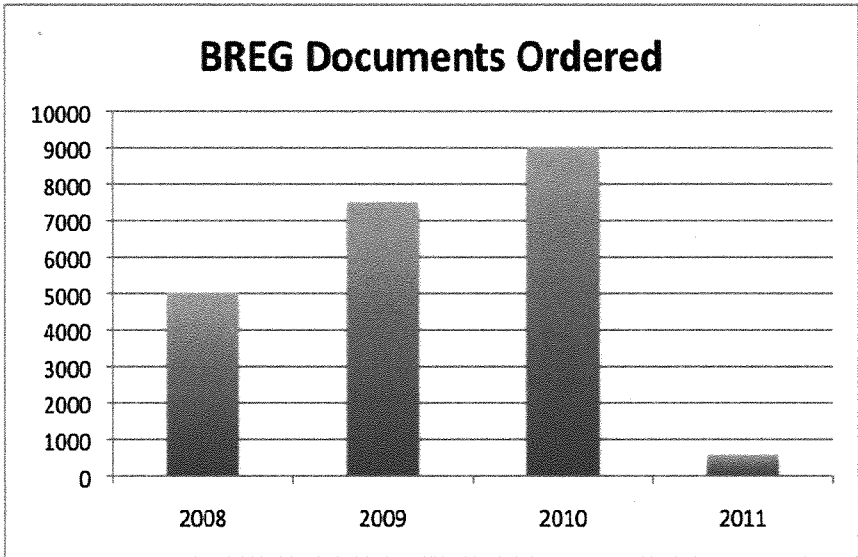

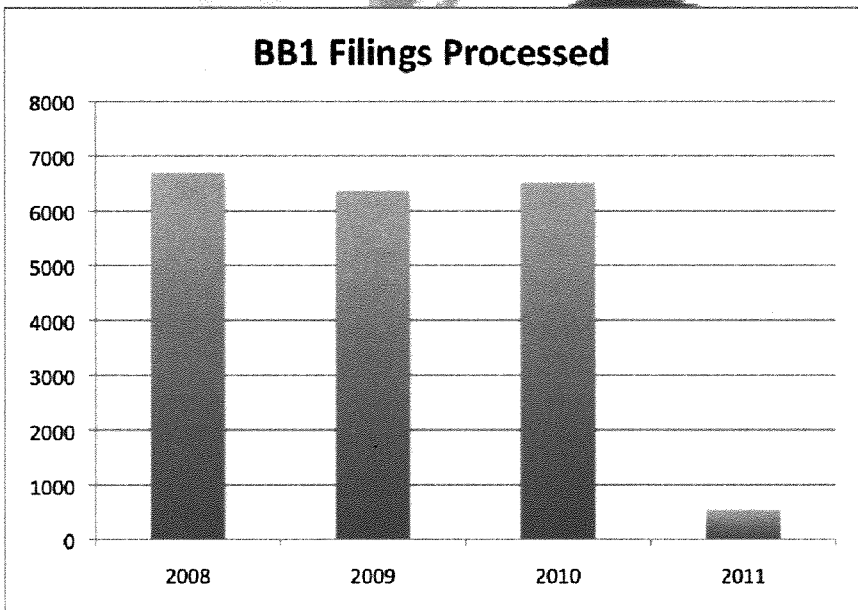

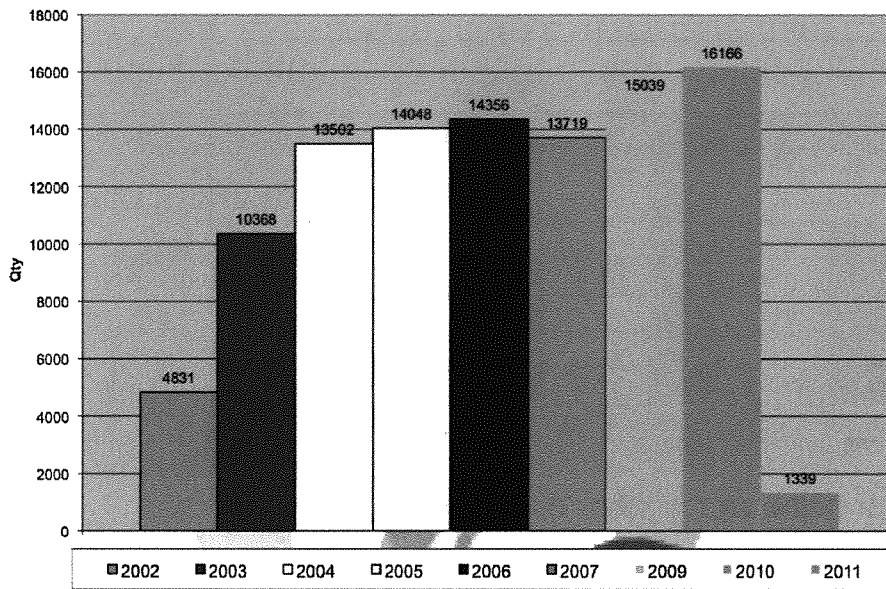


**Chart 3: Online DCCA BREG Documents ordered**



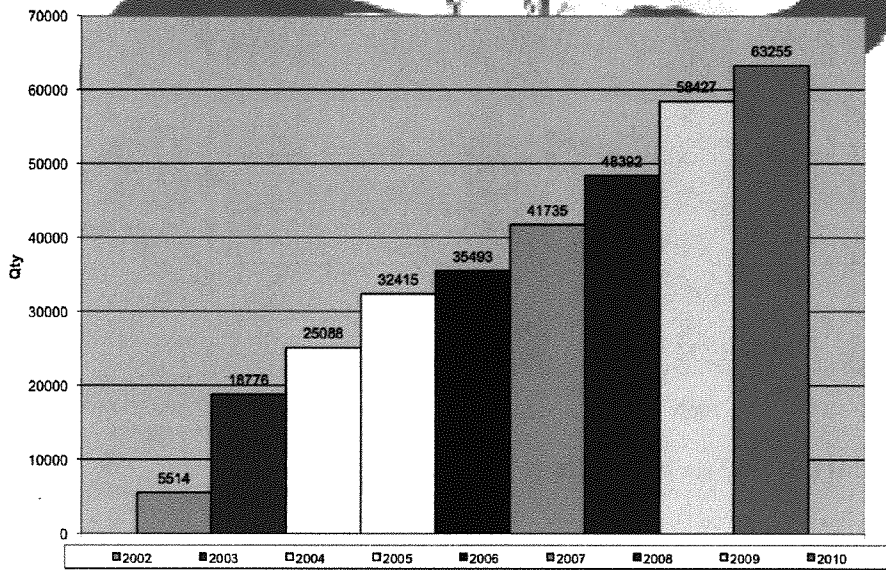
**Chart 4: DoTax BB1 Filings processed**

**BREG Online Filings Trend**

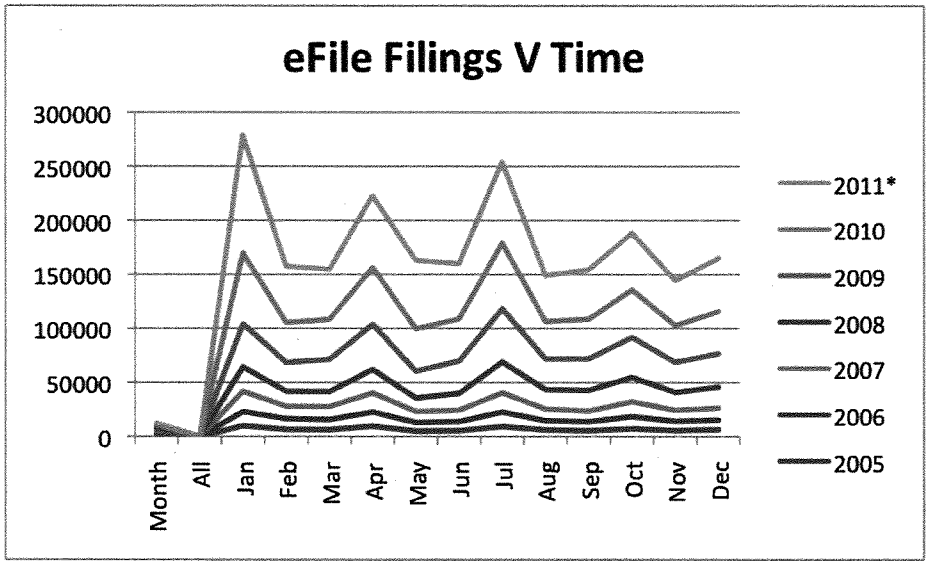


**Chart 5: DCCA BReG Initial Filings**

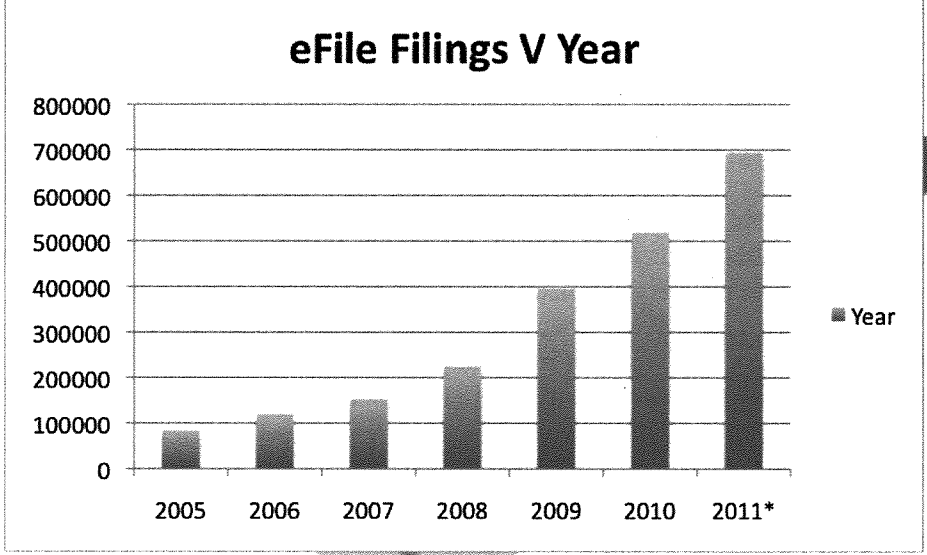
Annals Filed By Year

ADDED VALUE - AVOIDED COSTS - 2010

---

Each portal partner had manual processes, which were the baseline for doing business with the division. A form is submitted, the form information must be reviewed and entered into the computer system, the form must be scanned (of filed), workflow must commence and a confirmation communicated. Through the portal program partners and HIC have transformed many divisions from being paper-oriented to being customer-focused. In optimizing division workflows with modern technology and leveraging the Internet, divisions realize huge savings each year.

Decreased labor is one area in which there are significant savings. However it is difficult to calculate a reliable number. Tax collection is an area where much research has been completed. The IRS says that it costs roughly \$2.87 to process a paper form (not validate, just enter it), versus \$0.35 for an electronic filing. The Georgia State Department of Revenue found that it costs roughly \$8.00 to process and review each paper filing. These numbers do not include the processing of the payment associated with the filing.

Forms vary in complexity greatly. Electronic annual filings are largely automated, requiring no review at all, while initial filings do require review for name clearance, but most other fields are validated (addresses, agent information, fees, etc.) Some partners are also largely automated since the validations that take place are extensive. Specific licensees can be selected for audit after the renewal is processed, without impacting the renewal process and license statuses are updated in a matter of hours (due to mainframe integration.)

Mailing, printing and postage is another area of significant avoided cost. Beginning in 2005, the Portal began printing the renewal forms and postcards for BREG and PVL. Insurance was added in 2007. The partner typically pays for postage in these cases. We also began to change the way that notifications were sent out at that time:

- The Portal sends out email reminders for renewals on the first business day of the new cycle.
- After two to six weeks (depending on the division) postcard reminders are sent out only to those who have not yet renewed online.
- After another two to four-week delay, the paper forms are mailed out.

This process continues today with the exception that most divisions are phasing out mailing the paper forms completely.

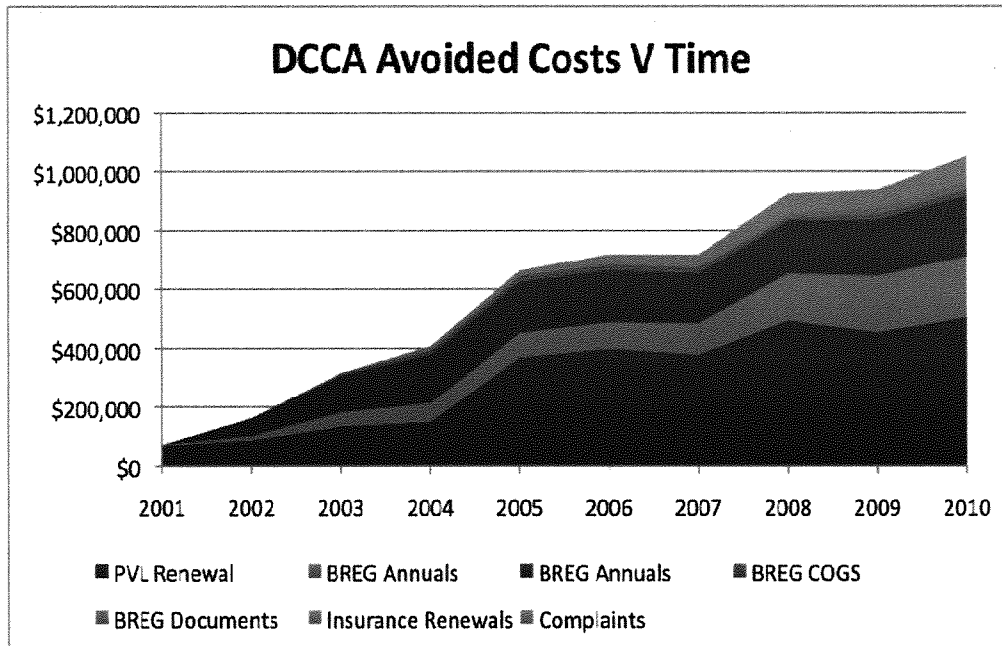


Chart 9: DCCA Avoided Costs

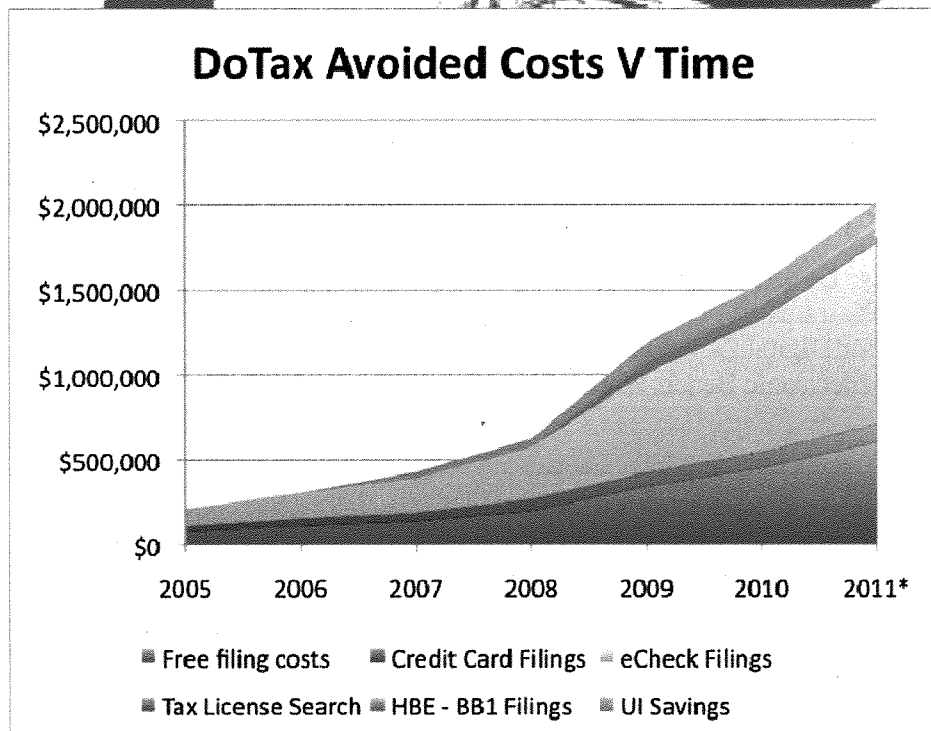
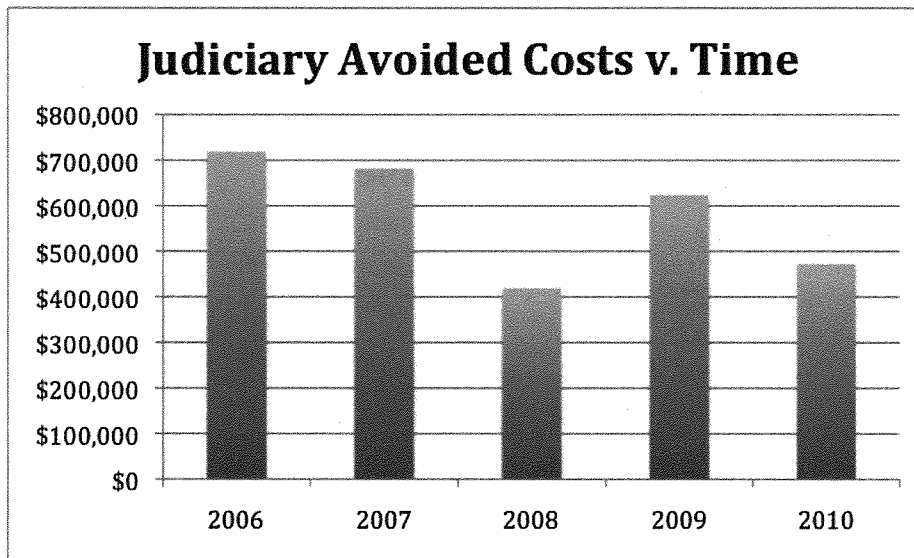


Chart 10: DoTax Avoided Costs

**6.45 Average Pages Per Visit:**

These are the average number of pages viewed by each visitor to eHawaii.gov.

**4:55 Time on Site:**

This is the average time each visitor spends visiting eHawaii.gov.

**30.79% Bounce Rate:**

The bounce rate is the percentage of single page visits or visits in which the person left your site from the entrance page. In other words, a bounce is an exit that was also an entrance. For example, if the page had 100 visits and 10 of those were entrances (they didn't come from another page on your site), if 5 of those entrances immediately exit (don't view any other page on the site), the bounce rate would be 50%. 5 out of 10 entrances were exits.

This statistic tracks users' new visitors to eHawaii.gov. This is tracked via cookies, which are pieces of text hosted in the users' browser.

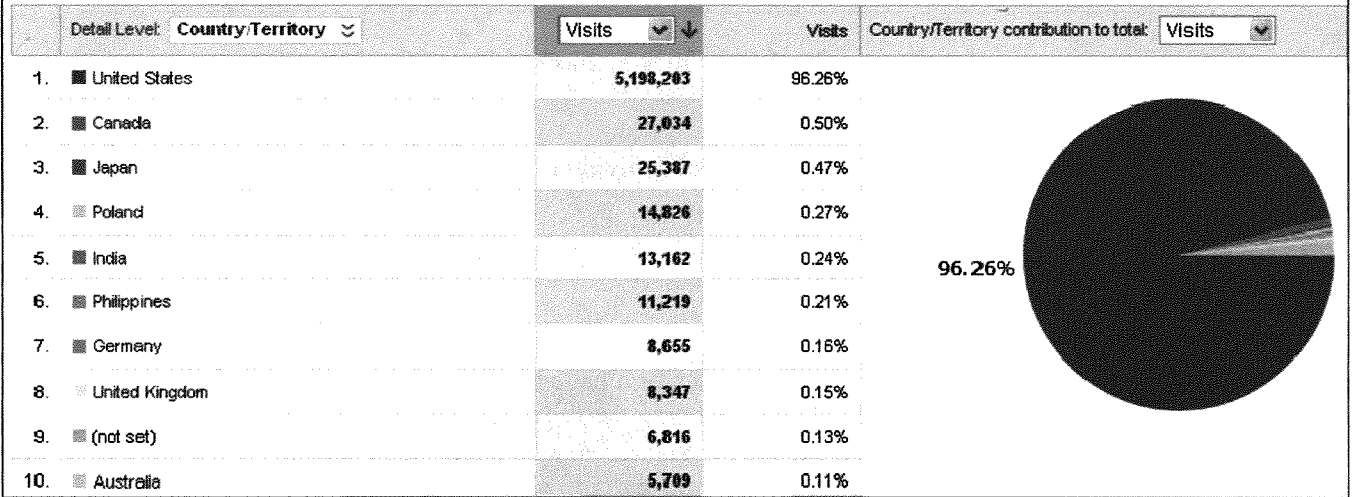

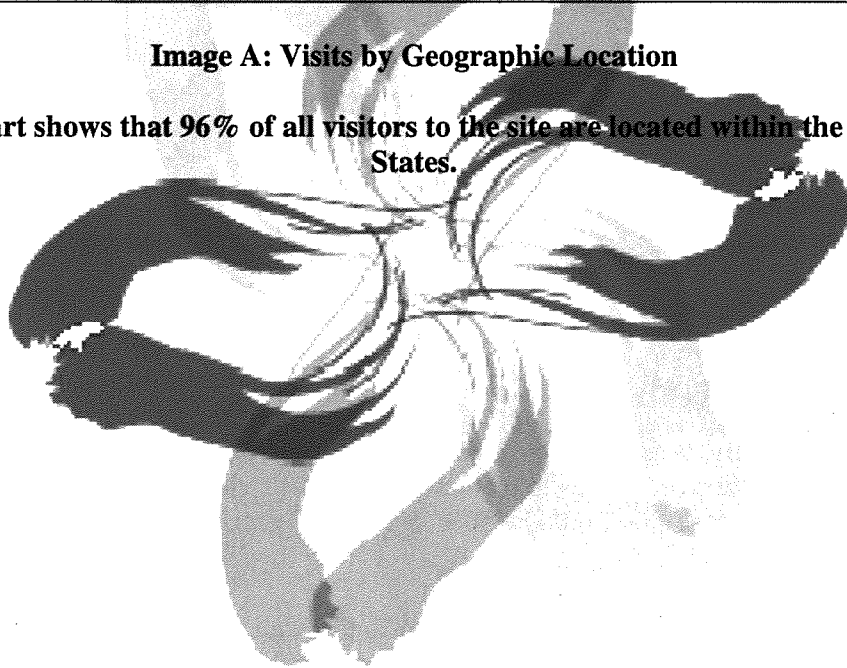

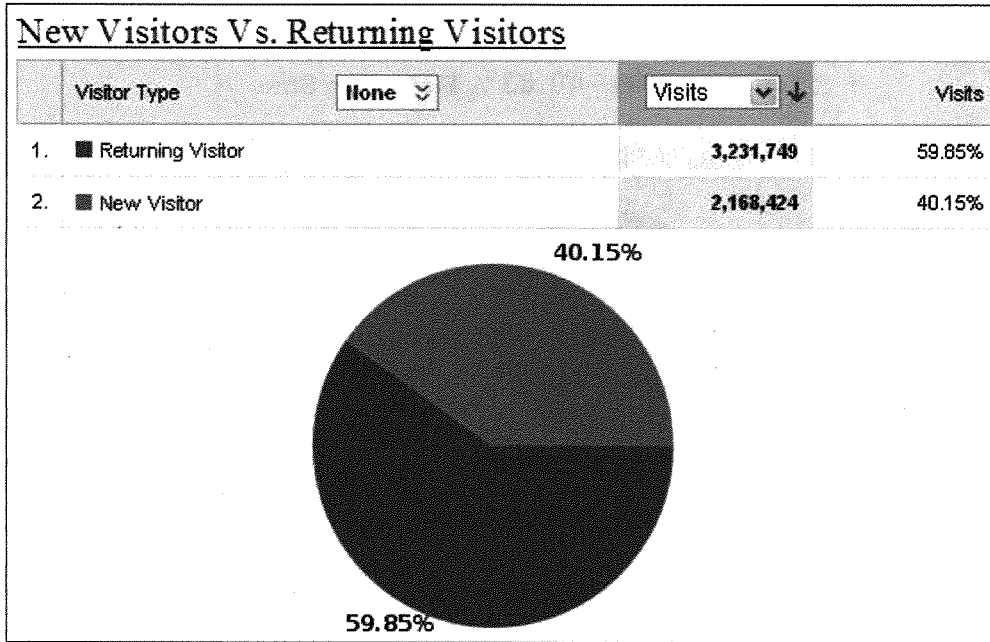

**Image A: Visits by Geographic Location**

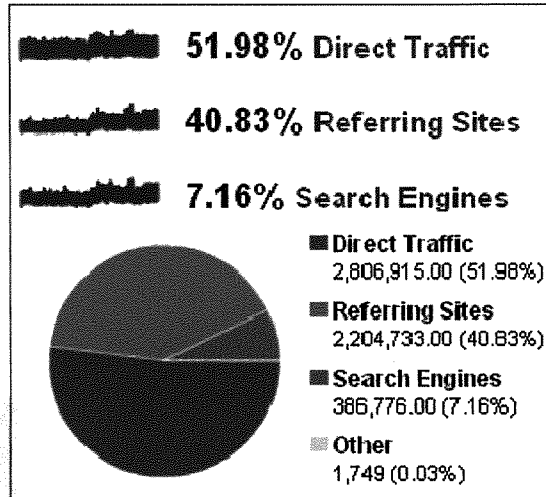
**This chart shows that 96% of all visitors to the site are located within the United States.**

PORTAL OBJECTIVES FOR 2010

---

- While work has been ongoing throughout prior years, a main focus of 2010 will be to redesign the current portal. Information will be easier to find, reorganized to be more intuitive to use, and include more frequently updated content. We will be utilizing various focus groups and individuals to assist us in our redesign efforts and are scheduled to launch in April 2011.
- Expanding county coverage throughout the islands. Our main focus will be the Big Island where 80% of the growth is estimated to occur in the coming years. Currently we are focusing on various CMS website redesign projects as well as the launch of online water payments, coming in late 2010 and early 2011. HIC may also considering relocating staff to the island to meet with agencies and discuss solutions to Big Island issues such as permitting.
- Enhancing our content management system to allow streamlined and quick development utilizing pre-set templates for all state and county partners. Set up should be quick with minimal to no development time needed.
- We will begin offering a new form processing service to our partners. This web based will assist state partners in eliminating simple paper forms by placing them online. The forms will be used for those that do not need direct back-end validation integration and have no payments associated with the service.

- Our award winning eBench warrants application will be released in the final major county, the County of Hawaii for use, bringing all major counties on board!

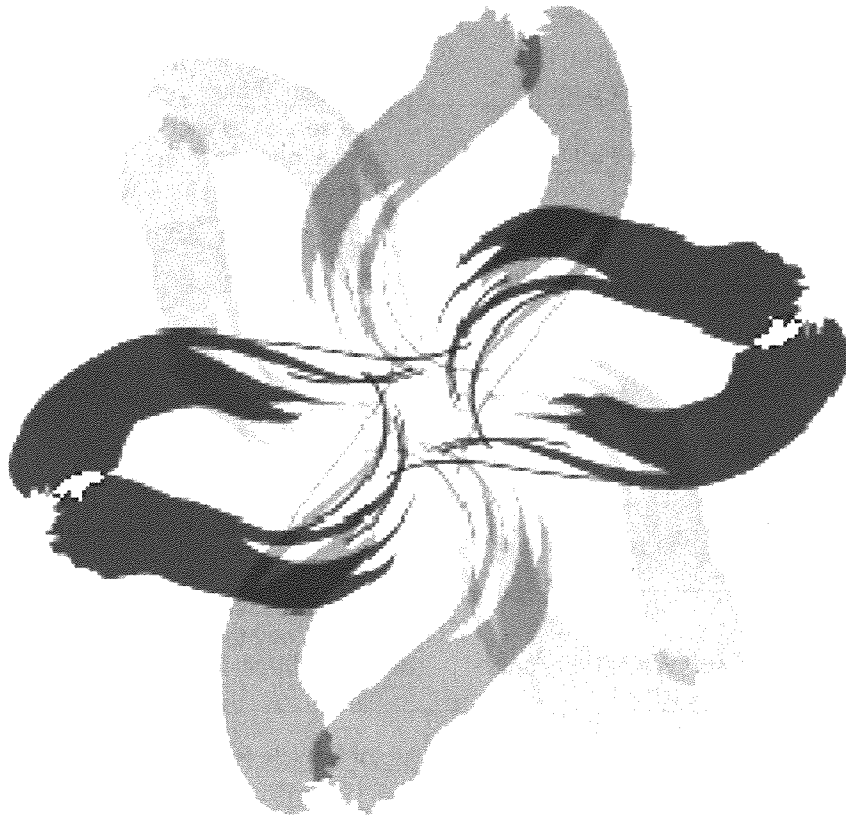
